Planning a Party on the Beach?

Of course AotB residents are welcome to do that, pursuant to common-sense regulations based on the need to respect nearby neighbors and our common environment, and on sound human judgment.

To reserve the beach for a party of 25 people or more from May through October, hosts must sign an agreement and post a deposit of \$500; they get it back unless our Beach Security representative detects failure to abide by the rules, which include –

- Start time no earlier than 12 noon and ending time no later than 9 p.m.
- Portable sanitary structures must be installed and removed; site to be cleaned up
- Unreasonably loud music is prohibited
- No on-street parking is permitted anywhere in the community
- There can be no blocking of access to/from any fire drafting site or residence
- The beach must be scrupulously maintained and returned in the same condition as it was found at the outset, with all trash collected and hauled out of the area
- Repair of any damage to the beach or neighboring property (including vehicle tire ruts on the ground) will be charged to the contracting party
- Swimming and other water sports may be enjoyed with no implication of safety responsibility for Arundel on the Bay.
